The Township of Maplewood recognizes the importance of having safe roads throughout the community. An efficient roadway system is important to the quality of life desired by citizens and insures continued economic vitality. Our goal is to ensure that drivers adhere to local laws and regulations to create a safe environment for automobile passengers, pedestrians and bicyclists.

The Township is conducting a survey to identify locations in need of traffic calming measures and/or traffic safety improvements. The purpose of traffic calming is to reduce the speed and volume of traffic to "acceptable" levels, based on standards of normal use, while maintaining an overall efficient transportation system. The intent of this survey is to obtain input from residents and civic groups to assist in the identification of these locations, the extent of the concerns and possible corrective measures.

The key objectives of this study are:

- Identify locations, along with their respective deficiencies, within the Township in need of traffic calming measures and/or traffic safety improvements.
- Identify possible corrective measures to address the identified deficiencies.
- Involve community stakeholders in the identification of deficiencies and possible corrective measures and throughout the entire study, design and construction process.
- Provide corrective measures that are pedestrian and bicyclist friendly.
- Provide corrective measures that are appropriately scaled and contribute to the quality of life and the sense of place.
- Coordinate with other municipal departments such as fire, police, emergency and parks and non-municipal agencies such as NJ Transit to allow for the proper access and circulation of their vehicles.
- Avoid relocating the traffic problem to another street or section of the Township.
- Ensure that the plan is compatible with other plans within the Township.
- Develop a plan that is cost effective and results in minimal physical impact to the surrounding areas.
